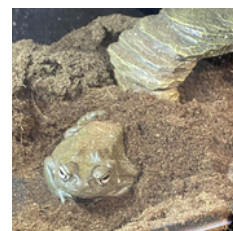
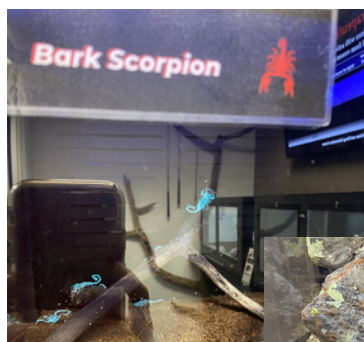

PROGRAM SPECIFICS

- DURATION: a 52-week Residency Year
- NUMBER OF POSITIONS: 2
- APPLICATION DEADLINE: **JANUARY 2**
- STAFFING REQUIREMENTS: AVERAGING ONCE EVERY **3rd WEEKEND**, 10-HR SHIFT SAT-SUN, FOLLOWING MONDAY OFF

ELIGIBILITY

- Graduation from an ACPE-accredited Doctor of Pharmacy (PharmD) program
- U.S. citizenship or legal authorization to work in the U.S. for the entire duration of the residency
- Ability to begin the residency on July 1, 2026
- Arizona pharmacist licensure (following successful completion of the NAPLEX and Arizona MPJE)
- Successful completion of:
 - A required employment physical
 - Drug screening
 - Background check
